### **GENERAL REVIEW AND DISCUSSION OF INTEGRATED MANAGEMENT PLAN STAKEHOLDER MEETING**

Onnen reported on the IMP Stakeholder Meeting held on March 29 in Hastings. Discussion was held and comments were received from the public regarding the meeting.

### **WATER RESOURCES COMMITTEE REPORT**

A Water Resources Committee meeting was held prior to the regular meeting.

#### **Discussion on Meter Maintenance Program**

Discussion was held on the meter maintenance program. A concern from the public was received regarding the change from free meter maintenance to those that participated in the volunteer reporting program to the District now only providing the labor to repair meters.

#### **Discussion of Concept of Allowing Sales of Water Rights in Stay Area**

The District has received questions on the possibility of allowing sales of water rights, discussion was held on this, no action was taken.

#### **Public Comment on Water Concerns**

Several members from the public expressed concerns for the continuing irrigation well development in the area east of Hebron. A meeting will be held in early May to discuss the matter further. Suggestions were taken from the public for future meeting topics.

## **PROJECTS AND PLANNING COMMITTEE REPORT – Marlin Kimle**

A Projects and Planning Committee meeting was held prior to the regular meeting.

### **Buffer Strip Applications**

Two Buffer Strip Applications were presented for approval. **MOTION # 6 – Kimle moved, seconded by Kissinger to approve the buffer strip applications of Goetzen & Ensz for 9.1 acres in Jefferson County with an annual payment of \$2,047.50; and Jed Weise for 2.99 acres in Jefferson County with an annual payment of \$672.75.** Carried by roll call vote – 15 yes votes.

### **Action to Approve Engineering Firm for Prairie Lake Developments**

Three quotes were received for engineering services for updates being made to Prairie Lake. **MOTION # 7 – Kimle moved, seconded by Brakhahn to approve quote for services of Frontwater Engineering LLC for design, plans and specs, bidding assistance and construction observation for an amount not to exceed \$13,250.** Carried by roll call vote – 15 yes votes.

### **Request for Long-Term Lease at Prairie Lake**

There is public interest in a multi-year prairie hay lease for Prairie Lake. **MOTION # 8 – Kimle moved, seconded by Wiedel to accept multi-year land lease bids up to 5 years for the harvest of prairie hay at the Prairie Lake Property.** Carried by roll call vote. Yes: Brakhahn, Cunningham, Else, Fisher, Fleharty, Hoffman, Kellogg, Kimle, Kissinger, Rainforth, Schroer, Wiedel and Uhrmacher. No: Hergott and Thomas.

### **Action to Approve Changes to District's Erosion and Sediment Control Program**

Changes were made to the District's Erosion and Sediment Control Program and were presented for approval. **MOTION # 9 – Kimle moved, seconded by Rainforth to accept the Little Blue NRD's Erosion and Sediment Control Program as proposed and offer the rules and regulations for public hearing on May 10, 2016.** Carried by roll call vote. ### **Action to Establish Hearing Date for Park Regulations**

With the planned improvements for Prairie Lake the Recreation Area Rules and Regulations are being updated. **MOTION # 10 – Kimle moved, seconded by Brakhahn to conduct a public hearing on May 10, 2016 for the purpose of amending the Districts Park Rules and Regulations for Recreation Areas to include references to model airplane uses.** Carried by roll call vote.
