### **Groundwater Transfer Request for Michael Haake**

A transfer request for Michael Haake was presented for approval. **MOTION # 6 – Brakhahn moved, seconded by Kissinger to approve the groundwater transfer request of Michael Haake from the NE¼ 27-T4N-R1E to the N½ SE¼ 27-T4N-R1E, Jefferson County.** Carried by roll call vote – 15 yes votes.

### **Transfer Request for Alan Wiedel**

A transfer request for Alan & Gregg Wiedel was presented for approval. **MOTION # 7 – Brakhahn moved, seconded by Hoffman to approve the groundwater transfer request of Alan and Gregg Wiedel from the NW ¼ 17-T2N-R3W to the NE¼, SE ¼ and SW ¼ 17-T2N-R3W, Thayer County.** Carried by roll call vote. Yes: Brakhahn, Fleharty, Hergott, Hoffman, Kellogg, Kimle, Kissinger, Meyer, Rainforth, Schroer, Shaw, Spencer, Thomas and Uhrmacher. Abstain: Wiedel.

### **Well Spacing Variance Request for Mark Kimle**

A variance request on well spacing was presented for approval. **MOTION #8 – Brakhahn moved, seconded by Hoffman to approve the variance request of Mark Kimle for the placing of a new irrigation well in the E ½ SE ¼ 16-T7N-R12W Adams County closer than the NRD 1,000 foot spacing rule, but require that the minimum 600 foot spacing still be enforced according to state law.** Carried by roll call vote. Yes: Brakhahn, Fleharty, Hergott, Hoffman, Kellogg, Kissinger, Meyer, Rainforth, Schroer, Shaw, Spencer, Thomas, Wiedel and Uhrmacher. Abstain: Kimle.

### **PROJECTS COMMITTEE – Marlin Kimle**

The Projects and Planning Committee met prior to the regular board meeting.

### **Discussion of Liberty Cove Bathymetric Survey Status**

FYRA Engineering attempted to conduct the bathymetric survey of Liberty Cove but due to the pondweed was unable to do so. They offered to do a survey manually this fall. **MOTION # 9 – Kimle moved, seconded by Brakhahn to forgo the contract with FYRA for the bathymetric survey at this time and cooperate with DEQ to do some lake investigations to determine what management options are available to improve lake water quality.** Carried by roll call vote – 15 yes votes.

### **Action on Cost-Share for Dam for Lyle Schroer**

A dam cost-share was presented for approval. **MOTION # 10 – Kimle moved, seconded by Wiedel to give tentative approval and planning authorization for the design of the Schroer dam in SE ¼ 22-3N-R8W, Nuckolls County with the intent to provide 80% cost-share.** Carried by roll call vote. Yes: Brakhahn, Fleharty, Hergott, Hoffman, Kellogg, Kimle, Kissinger, Meyer, Rainforth, Shaw, Spencer, Thomas, Wiedel and Uhrmacher. Abstain: Schroer.

### **Action on Stream Gauge Contract with DNR**

A contract with DNR for installation and maintenance of two stream gauges was presented for approval. **MOTION # 11 – Kimle moved, seconded by Thomas to sign the proposed contract with NeDNR on stream gauges for the Hebron and Rose Creek Sites for the construction and operation of the gauges as presented, and move funds from the Monitoring Well Development budget category to a Stream Gauge Program budget category to facilitate immediate installation of the gauges.** Carried by roll call vote – 15 yes votes.

**MOTION # 12 – Kimle moved, seconded by Thomas that contingent on the approval of Thayer County, to sign a contract with USGS for the installation and operation of the stream gauge at Highway # 5 with anticipated costs as presented, and move funds from the Monitoring Well Development budget category to a Stream Gauge Program budget category to facilitate immediate installation of the gauges.** Carried by roll call vote – 15 yes votes.

**Action on Village of Hubbell Drainage**

A request for assistance with drainage improvements from the Village of Hubbell has been received.

**MOTION # 13 – Kimle moved, seconded by Fleharty to approve the Urban Conservation**

**Assistance cost-share request of the Village of Hubbell for drainage improvements and match the Village’s project funds up to a five-year period at 50% of the actual cost not to exceed \$20,000.**

Carried by roll call vote – 15 yes votes.
