**Groundwater Monitoring Wells/Geologic Investigations**

Orvis reported on the meeting held with the Rural Water Advisory Board on May 2. **MOTION # 8 – Kissinger moved, seconded by Rainforth to accept the report of the LBPWP Advisory Board.** Carried by roll call vote. **ACTION ON STREAM GAUGE AGREEMENT WITH LOCAL SPONSORS**

A contract with JEO/LBG to conduct the next round of water retention structures for Water Sustainability Funding was presented for approval. **MOTION # 10 – Fleharty moved, seconded by Rainforth to approve the contract with JEO/LBG for professional services associated with surface water capture and recharge projects.** Carried by roll call vote.
