MOTION # 4 - Brakhahn moved, seconded by Rainforth to approve the report and payment of bills as presented. Carried by roll call vote – 17 yes votes.

Brakhahn reviewed the Little Blue Public Water Project - South Treasurer's Report. **MOTION # 5 - Brakhahn moved, seconded by Hergott to approve the report and payment of bills as presented.** Carried by roll call vote – 17 yes votes.

FY 2016 AUDIT REPORT – Christy Hadden

Copies of the Little Blue NRD, Little Blue Public Water Project and Little Blue Public Water Project - South audits for the year ending June 30, 2016 were presented to the Director's. Christy Hadden from Schulz & Associates P.C. of Fairbury was present to review the audits and answer questions. **MOTION # 6 – Hergott moved, seconded by Kissinger to approve the FY 2016 audit report conducted by Schultz Associates for the District, the Little Blue Public Water Project and Little Blue Public Water Project-South.** Carried by roll call vote – 17 yes votes.

PROJECTS COMMITTEE MEETING REPORT – Marlin Kimle

The Projects and Planning Committee met prior to the regular meeting.

Action on Bids for Tye No-Till Drill

Bids were received for the Tye No-Till drill. **MOTION # 7 - Kimle moved, seconded by Fleharty to accept the bid of Lee Peshek of Clay Center in the amount of \$2,825 for the 2001 Tye Drill.** Carried by roll call vote – 17 yes votes.

Action to Amend Cost-Share for Dam Program Agreement Term

Staff held a discussion with NRCS on the cost-share for dams program and issues from the past.

MOTION # 8 – Kimle moved, seconded by Fleharty to change the contract period for dams constructed under the Cost-Share for Dams Program to 25 years.

Carried by roll call vote. Yes: Brakhahn, Cunningham, Else, Fisher, Fleharty, Kellogg, Kimle, Rainforth, Wiedel and Uhrmacher. No: Heinrichs, Hergott, Hoffman, Kissinger, Schroer, Spencer and Thomas.

MOTION # 9 – Kimle moved, seconded by Fleharty to change the Cost-Share for Dams Program to encourage three bids, but have some leniency if only two bids can be received.

Carried by roll call vote – 17 yes votes.

MOTION # 10 – Kimle moved, seconded by Rainforth to allow the dams that are being constructed under the current policy to be completed with the value of the land figured as a portion of the landowners share, but remove that criteria for calculating land value as a portion of the landowner’s share for any dams applied after November 8, 2016.

Carried by roll call vote. Yes: Brakhahn, Cunningham, Else, Fisher, Fleharty, Heinrichs, Kellogg, Kimle, Kissinger, Rainforth, Schroer, Spencer, Thomas, Wiedel and Uhrmacher. No: Hergott. Absent: Hoffman.

Discussion of Rural Water Supply and Future Users

This item was tabled until the December meeting.

Discussion and Possible Action on Groundwater Recharge Projects

Groundwater recharge projects are a Watershed Management Plan objective. **MOTION # 11 – Kimle moved, seconded by Rainforth to solicit proposals from consulting firms to investigate groundwater recharge and flood control site options in the District.** Carried by roll call vote – 17 yes votes.

REPORT OF FALL 2016 GROUNDWATER LEVELS

Orvis presented the results of the static water level readings from this fall. The levels are 0.23 feet lower than last fall.

DISCUSSION ON PLANS FOR BOARD GROUNDWATER WORKSHOP

Discussion was held on the Board Groundwater Workshop being planned to discuss water quality and quantity issues.

GENERAL DISCUSSION ON DIRECTION FOR GROUNDWATER MANAGEMENT PLAN

Additional discussion was held on possible modifications to the District’s Groundwater Management Plan.
