# PROJECTS AND PLANNING COMMITTEE REPORT

The Projects and Planning Committee met May 7.

#### **Discussion on Field Ponding Issues from Sand Creek Weir's**

There was concern the weirs under construction southwest of Holstein were causing springs to come up in a field. Robert Lutz of EA stated the weirs were well below the wet spots. The committee recommended the situation be monitored.

#### Discussion and Possible Action on FEMA/NRCS Funding for Sand Creek Weir Repairs

Damages occurred to the weirs project due to high velocity of water and no vegetation during the recent flooding. MOTION # 9 – Rainforth moved, seconded by Shaw to seek available funds for weir repairs and ditch work from FEMA and NRCS. Carried by roll call vote – 15 yes votes.

#### Action on Sand Creek Weir Repair Costs

An estimated cost for repairs to the weir project was presented. <u>MOTION # 10 – Rainforth moved</u>, <u>seconded by Brakhahn to approve the estimate from EA in the amount of \$35,740 for all 5 weirs in</u> <u>Adams County sections 29-06-12 and 18-06-12</u>. Carried by roll call vote – 15 yes votes.

#### Action on Ditch Work for Villages of Reynolds, Belvidere and Hubbell

Three villages have requested assistance through the District's Urban Conservation Program.

in the amount of \$36,067.63. Carried by roll call vote. Yes: Brakhahn, Glenn, Hergott, Hoffman, Kellogg, Kissinger, Meyer, Rainforth, Shaw, Taylor, Trausch, Wiedel and Kimle. No: Heinrichs and Hollister.

MOTION # 12 – Rainforth moved, seconded by Hoffman to approve the Belvidere drainage project in the amount of \$3,003.04. Carried by roll call vote – 15 yes votes.

One Buffer Strip application was presented for approval. <u>MOTION # 14 – Rainforth moved, seconded</u> by Brakhahn to approve Tri C Buffer Strip Section 35-2-6 NE1/4 for annual payment of \$326.80 for <u>10 years.</u> Carried by roll call vote – 15 yes votes.

#### Action on Transfer Pipe Cost Share Payment

A buried pipe cost share application was presented for approval. <u>MOTION # 15 – Rainforth moved</u>, <u>seconded by Meyer to approve LBNRD to pay Rippen's a total of \$3,136.00 for the buried pipe in</u> <u>sections 26-06-08 and 21-06-08</u>. Carried by roll call vote – 15 yes votes.
