#### **Action to Approve MOA for NRCS**

The Memorandum of Agreement with the NRCS was presented for approval. Motion #6 – Shaw moved, seconded by Brakhahn to Approve Memorandum of Agreement (MOA) for NRCS. Carried by roll call vote – 17 yes votes.

The Projects and Planning Committee met prior to the regular meeting.

# **Action to Approve Shickley Drainage Application**

A drainage project for the Village of Shickley was submitted for approval. MOTION # 7 – Glenn moved, seconded by Kissinger to approve Village of Shickley drainage application in the amount of \$7,365.50. Carried by roll call vote – 17 yes votes.

## Action to approve Well Data Logger for Oxbow Project

Bids were taken for the installation of a data well logger for the Oxbow Project and three bids were received. MOTION #8 – Glenn moved, seconded by VonSpreckelsen to accept the bid of \$9,361 from In-Situ for the well data logger for Oxbow Project. Carried by roll vote – 17 yes votes.

# Action to Begin USDA Application Process for Rural Water Project

Options were received from the USDA for the purchase of water for the District's Rural Water Projects. Discussion was held and comments were received with concerns the NRD staff was withholding information from the Water Projects Advisory Board. MOTION #9 – Glenn moved, seconded by Hoffman to approve beginning the USDA application process for the Rural Water Projects to purchase water from the Village of Alexandria at \$0.91 per thousand gallons and a monthly meter fee of \$388. Carried by roll call vote – 17 yes votes.

## Action to Approve Solicitation of Bids for NRD Vehicle and WP Vehicle

Money for the purchase of a pickup for both the District and the Rural Water Projects was included in the budget. MOTION # 11 – Glenn moved, seconded by Rainforth to approve solicitation of bids for the purchase of an NRD Vehicle and Water Projects Vehicle. Carried by roll call vote – 17 yes bids.

#### **Other Business**

Glenn presented a draft letter to the City of Fairbury explaining the Water Projects process and decision to pursue the purchase of water from other sources. MOTION # 10 – Glenn moved, seconded by Kissinger approve a letter to communicate with City of Fairbury about future water partnerships. Carried by roll call vote – 17 yes votes.

## APPOINT NOMINATIONS COMMITTEE FOR 2020 ELECTIONS

Warren Brakhahn, Jesse VonSpreckelsen and Bill Glenn were appointed to serve as the Nominations Committee for the January 14, 2020 Board meeting elections.

## **OTHER BUSINESS**

Goeschel distributed a list of Goals and Objectives to be included in the 2019 Master Plan and requested everyone rank the list in the order of importance. Kissinger requested the District speak to a producer regarding a drainage problem south of Fairfield.
