

# Little Blue NRD

## 2022 Tree Program Policy

### District Plants

1. The minimum order for a District Plant is 100 trees. All orders must be submitted to the Little Blue NRD office before **March 15th** of the planting spring. All District plant orders submitted after that cut-off date will not be accepted. The District will accept hand plant orders until supply is eliminated.
2. The cost per tree is **\$1.25** plus sales tax, planting charge is **\$1.25** per tree plus sales tax. The minimum amount for a District Plant is **\$131.88 (5.5% sales tax)**; this will be charged even if we plant less than 100 trees. If we plant less than 100 trees, no 'extras' will be left unless requested on the tree plan. Cost-share will be lost if the planting does not have at least 100 trees. **Trees must be ordered in multiples of 25.**
3. Payment for the trees ordered is due when the tree plan is forwarded to the District's office. The District will bill for the planting charge and any adjustment for the number of trees planted upon completion of the project. If the NRCS estimates are not met and indicated that extras are wanted, we will leave the trees at a suitable on-site location or issue a refund or billing statement.
4. Sites must be adequately tilled to ensure proper planting conditions; the District doesn't recommend planting into sod. *We offer a roto-tilling service*; however, it works best as secondary tillage after fall plowing or heavy disking. **If the site is not adequately prepared, the trees will be left at the planting site and not planted by the District.**
5. The District has a "No-Replacement Policy" on the loss of district or hand-planted trees. In the event of a significant death loss due to poor nursery stock or negligence on the District's part, the District will determine if the trees should be replaced at a cost to the District or the nursery stock provider.

### Weed Barrier

1. Minimum application is 300 feet.
2. Cost of the weed barrier is **\$0.75** per linear foot plus sales tax. The installation charge is **\$0.75** per linear foot plus sales tax. The minimum amount for a weed barrier application is **\$237.38 (5.5% sales tax)**; this will be charged even if we apply less than 300 feet.
3. Payment of 75% of the total (material) weed barrier cost must be made when submitting a tree plan. The producer must sign an order acknowledging the estimated charges and that they will be charged for actual linear feet installed. The installation fee will be paid upon completion of the project. The signed, original weed barrier order must be sent along with the tree plan.
4. Sites with weed barrier must be adequately tilled to a width of 10 feet. This is a necessity to ensure the proper application of the weed barrier. Weed Barrier will not be laid on curves or side hills unless the Little Blue NRD obtains prior approval.
5. The weed barrier must be cut back after 3-4 years to prevent girdling.

## **Hand plants**

1. Trees may be ordered for any number of any species. Cost is **\$1.25** per tree plus sales tax and a **\$2.00** wrapping/handling fee plus sales tax per order. The handling fee does not apply to a District Plant that requests extra trees left after planting. **Trees must be ordered in multiples of 25.**
2. Payment is to be received at the time the order is placed. The trees may not be picked up until payment is received.
3. Please designate on the order form if the hand plants are to be picked up at the NRD office, the county NRCS office, or other arrangements. The trees will be delivered to the NRCS office in the county designated on the order form.
4. There will be no cancellations of hand plant orders.

## **Replacement Policy**

1. **The District has no replacement policy on the loss of district or hand-planted trees.**  
In the event of a significant death loss, the district will determine if the loss was due to poor nursery stock, negligence on the District's part, poor site conditions, neglect by the customer, or other factors.  
Only if losses are determined to be poor nursery stock or negligence on the part of the district, the District will negotiate a settlement or replacement plan on a case-by-case basis.

## **Site Preparation for Tree Planting**

1. **Please follow site Preparation recommendations in the "Site Preparation brochure" to ensure the best planting conditions.**
2. **The Little Blue NRD will have the right to reject any unsuitable ground preparations and **leave the trees at the tree site and not continue planting.****
