The Little Blue Natural Resources District (LBNRD) took 325 water samples from irrigation wells this past summer.

If one of your wells was one that was tested, you received a postcard from us telling you your well's nitrate result and how to figure out the nitrogen credit associated with it.

Nitrates are down from the previous year in most all of the LBNRD which is great to see. Average nitrates within water quality sub-areas came in at 10.6 parts per million (ppm), still above the EPA's maximum contaminant level (MCL) of 10 ppm, but down 0.6 ppm from a year ago. Average nitrates outside of water quality sub-areas were 5.7 ppm, up slightly from a year ago. While it's great to see a slight tick down this year in areas with historically high nitrates, long term trends are

still rising.

Nitrates in Nebraska's groundwater is a serious issue facing our state. Nitrates are responsible for higher rates of blue baby syndrome and have been correlated to higher rates of various cancers, also, making elevated nitrates a significant public health issue.

The best way a farmer can reduce nitrates in groundwater is to apply nitrogen fertilizers when the crop is able to take up the excess nutrients, and in the right amount, only giving the plant what it needs, not more or less.



Fiscal Year 2022 Budget Approved by: Marie Herbek

The Little Blue NRD Board of Directors approved the FY 2022 budget of \$4,168,252 with a tax levy of .020879 at their September 14th meeting. Included in this budget is the Rural Water Project North budget of \$286,004, and the Rural Water Project South budget of \$263,106.

FY 2022 BUDGETED INCOME

Some of the projects included in the budget are:

Installation of 20 electrical camper pads at Prairie Lake Recreation Area just southwest of Hastings. Updated double restrooms at both Lone Star and Liberty Cove Recreation Areas. A grant application has been submitted to the Nebraska Game & Parks and if approved Lone Star will receive an additional single restroom and both recreation areas will have new playground equipment installed.

Partial remodel of the district's office to create three separate offices and painting throughout the building. Funding for this will come from sinking funds already set aside for the project.

Completion of the Kenesaw Watershed Study to seek solutions to flooding issues.

Completion of the All-Hazard Mitigation Plan Update

which is a joint effort with the Lower Big Blue NRD with funding coming from the Federal Emergency Management Agency.


Continuation of the Blue River Basin Modeling project being done in cooperation with the Upper Big Blue and Lower Big Blue NRD's. NE Department of Natural Resources is paying for 50% of this project.

Urban Conservation Program grants being provided to four towns and villages within the district to be used on drainage issues.

Urban Park & Recreation Program grants to four towns.

Search for a new water source for the Rural Water Projects and seek funding through grants and loans from USDA Rural Development.

FY 2022 BUDGET EXPENSES

Other items included are cost-share assistance for land treatment, irrigation, and water quality practices; dam cost share; tree program; buffer strip payments; flow meter maintenance.

Participating schools were Lawrence-Nelson, Shickley, Sutton Christian, Deshler Lutheran, Sutton Public and St. Michaels in Hastings.



Area 6 Range Judging Competition by: Jessica Hedges



We had 18 schools bring their Future Farmers of American Programs to Hebron to test their skills. Participating schools were Blue Hill, Bruning-Davenport, Deshler, Hastings St. Cecelia, Johnson-Brock, Lawrence-Nelson, Lewiston, Meridian, Milford, Norris, Osceola, Palmyra, Red Cloud, Sandy Creek, Superior, Sutton, Syracuse, and Tri-County.

In the Senior Competition, the winner was Noah Niemeyer from Norris, closely followed by Nicholas Loxterkamp(Second place) and Carter Siems (third place) of Tri-County. The team winner was the team from Norris, consisting of Noah Niemeyer, Grace Kohler, Anna Rahrer, and Kate Osterhaus. Prairie Lake Construction Update

Over the past year, the Little Blue Natural Resources District has set in motion a plan to develop electrical RV camping at Prairie Lake and in June, hired Consolidated Concrete to construct 20 RV camping pads.

In October, Ideal Electric was hired to install 30/50 Amp electrical pedestals at each pad and to date, approximately 75% of this work is complete. The Little Blue NRD staff spent a few days in October making the area the best that it can be by planting shade trees and installing fire rings at each pad. Each pad will also be outfitted with a picnic table which should be delivered and installed in November.

The Little Blue NRD is planning to have this New Camping Area open by April 1st, 2022.

Producers should start contacting local NRCS offices to get tree plans complete as soon as they can. Please do some research on tree species to choose what best fits their situation.

The producer must do adequate site preparation in the fall AND spring if they want cost-share on windbreaks.

It is recommended to elongate the slits in the weed barrier in the third year after the weed barrier has been installed to prevent girdling.
