

Rules and Regulations Changes

As of June 1st, 2023, a change to the water use reporting deadline of the "Groundwater Management Rules and Regulations" and several Recreation Area rules went into effect. We have listed below the rules and changes:

WATER USE REPORTING RULE CHANGE:

Water use reports were previously due on or before December 31st, of each year. However, Water use reports are now due on or before December 15th, of each year.

The New Rule Now Reads:

All agricultural water users, including recreational, fish & wildlife users, shall report to the District the groundwater withdrawal from each high-capacity water well he or she controlled for the calendar year on or before December 15th, of each year.

RECREATION AREA RULE CHANGES:

I.For All LBNRD Recreation Areas:

Previously, The use of flotation devices within designated swimming areas were prohibited, except for such devices approved by the Unites States Coast Guard. **Now:**

The use of flotation devices within designated swimming areas is permitted at your own risk.

2.At Bruning Dam Recreation Area:

Horseback riding is allowed on roadways and throughout the park. Riders should be aware that the area will be open for hunting and archery during the appropriate seasons.

3.At Liberty Cove Recreation Area:

Swimming and wading are permitted. These activities are "at your own risk." No lifeguards on duty. The district is not responsible for any accidents or loss of life.

2023 Tree Planting Season

This year was one of our most productive tree planting seasons yet! We sold a total of 7,552 trees across the district. 4,308 trees were planted by the purchaser. 2,700 trees were planted by district employees.

Adams County planted 1,475 trees, Clay County planted 1,025 trees, Fillmore County planted 125 trees, Jefferson County planted 725 trees, Nuckolls County planted 900 trees, Thayer County planted 2,073 trees, and the LBNRD planted 55 trees at our recreation areas.

The future of our natural resources lies in the hands of our children. Therefore, the Little Blue Natural Resources District feels youth education is a top priority. Earth Day and Arbor Day offer an excellent time for staff to visit elementary aged children and offer them gift – a free tree!

Spruce being the popular choice this year. Jessica was able to spend approximately ten hours of classroom time interacting with students ranging from prekindergarten to eighth grade. The point of focus during the presentations was the different parts of a tree, and what functions those parts provide for the tree.

Assessment and Information
Network needs your assistance.
We are in search of Volunteers
to report rainfall daily. We would
like an equal distribution of
Volunteers of all ages to report
rainfall amounts directly to a
website from your home. Each
participant will get a new quality
gauge and reporting forms.

The data compiled by this program can be used by crop

consultants and producers for making local irrigation application decisions. It will also assist in future developments of the models associated with the Platte, Republican, Blue and Loup Rivers and will be available for any additional studies where rainfall data would be needed. Data such as this can be used to better understand the distribution of large-scale storms, very localized storms, and the ability to project more accurate flood warning data.
