CALL MEETING TO ORDER – Jesse VonSpreckelsen

The Directors of the Little Blue Natural Resources District met in regular session on Tuesday, May 12th, 2026, at the Little Blue Natural Resources District Office, Davenport, Nebraska. Discussion/Action on the Purchase of Board Room Furniture – Nelson reviewed the proposed new board room furniture. **MOTION #5 – Hoffman moved to approve purchase of Board Room Furniture, seconded by Knight.** Carried by roll call vote – 16 yes.

Discussion/Action to Review and Approve Bids for LBPWP Bid Package #1. – Chris Miller with Miller & Associates reviewed the bids for LBPWP Bid Package #1 for Wells and Controls. **MOTION #6 – Paus moved to approve the low bid from Sargent Irrigation at \$1,666,022.00, seconded by Kenning.** Carried by roll call vote – 15 yes votes, Glenn abstained.

Discussion/Action to Review and Approve Bids for LBPWP Bid Package #2. – Miller reviewed the bids for LBPWP Bid Package #2 for Transmission Main and Booster Pump Station. **MOTION # 7 – Shaw moved to approve the low bid from Van Kirk Bros. Contracting at \$5,958,765.00, seconded by Hoffman.** Carried by roll call vote – 15 yes votes, Glenn abstained.

Discussion/Action to Review and Approve Bids for LBPWP Bid Package #3. – Miller reviewed the bids for LBPWP Bid Package #3 for a Ground Storage Tank. **MOTION #8 – Hoffman moved to approve the low bid package A from Van Kirk Bros. Contraction at \$408,195.00, seconded by Ochsner.** Carried by roll call vote – 9 yes votes, Bredthauer, Brinegar, Hoeft, Knight, and Paus – no, Glenn abstained.

2026 SPRING WATER LEVELS REPORT – Orvis reviewed the 2026 spring water level reports. Hydrogeologic Unit 2, having remained below the trigger level for 2 consecutive years, will move into allocations per our Rules and Regulations.

Discussion/Action on the Drilling of a Dual Cased Borehole Well near Edgar. – Knight presented information on a potential commercial well near Edgar. **MOTION #9 – Hoffman moved to support the project as presented, seconded by Paus.** Carried by roll call vote, 15 yes votes, Knight abstained.

Discussion/Action on GWMP Rule Changes – Nelson reviewed potential changes to the GWMP Rules. **MOTION # 10 – Hoffman moved to approve the GWMP Rule Changes, seconded by Walker.** Carried by roll call vote, 15 yes votes, Schroer – no.

Discussion/Action to set a Public Hearing Date & Time for GWMP and Recreation Area Rule Changes – Goeschel proposed July 14th at 6:30 pm and 6:45 pm for the Public Hearing Date & Time. **MOTION # 11 – Walker moved to set a Public Hearing Date & Time for GWMP and Recreation Area Rule Changes on July 14th, 2026 at 6:30 pm and 6:45 pm, seconded by Hoffman.** Carried by roll call vote, 15 yes votes, Schroer – no.

Discussion/Review of FY 2027 Budget – Nelson gave a brief overview of the upcoming budget for FY 2027. No action was taken.
