Carried by roll call vote – 15 yes votes.

<u>Discussion/Action to Sell the District's 2014 Ford F-150</u>: Due to the purchase of a new pickup the 2014 Ford F-150 will offered for sale. <u>Motion # 7 – VonSpreckelsen moved, seconded by Trausch to authorize staff to advertise the 2014 Ford F-150 for sale on Big Iron.</u> Carried by roll call vote – 15 yes votes.

<u>Discussion/Review Draft FY 2023 Budget:</u> Nelson gave a brief review of the progress of the FY 2023 budget.

Carried by roll call vote – 15 yes votes.

Review Preliminary Investigation Feasibility Report (PIFR) – West Branch 32 – Mile Creek Watershed: Information was provided on the proposed project on the West Branch Thirty-Two Mile Creek Watershed.

Discussion/Review Draft FY 2023 Budget: The FY 2023 budget was approved.

Other Business: No other business was discussed.

Motion #9 – Hoops moved, seconded by Shaw to authorize Leonard Rice Engineering to apply for a grant on the district's behalf to update the district's 2011 Hydrogeologic Study at a cost of \$6,000. Carried by roll call vote – 15 yes votes.
