**MOTION # 2 – Hoffman moved, seconded by Taylor to approve all consent agenda items.** Carried by roll call vote – 14 yes votes.

**MOTION # 3 – Meyer moved, seconded by Wiedel to approve the Little Blue NRD treasurer's report and payment of bills as presented.** Carried by roll call vote – 14 yes votes.

**MOTION # 4 – Meyer moved, seconded by Schroer to approve director per diem and expense for Brakhahn, Glenn, Heinrichs, Hergott, Hoffman and Kellogg.** Carried by roll call vote. Yes: Kissinger, Meyer, Schroer, Shaw, Taylor, Trausch, VonSpreckelsen, Wiedel and Kimle. Abstain: Brakhahn, Glenn, Heinrichs, Hoffman and Kellogg.

**MOTION # 6 – Meyer moved, seconded by Brakhahn to approve director per diem and expense for Taylor, Trausch, VonSpreckelsen, Wiedel and Kimle.** Carried by roll call vote. Yes: Brakhahn, Glenn, Heinrichs, Hoffman, Kellogg, Kissinger, Meyer, Schroer and Shaw. Abstain: Taylor, Trausch VonSpreckelsen, Wiedel and Kimle.

Meyer reviewed the Little Blue Public Water Project North Treasurer's Report.

**MOTION # 7 - Meyer moved, seconded by Schroer to approve the Little Blue Public Water Project North treasurer's report and payment of bills as presented.** Carried by roll call vote – 14 yes votes

Meyer reviewed the Little Blue Public Water Project South Treasurer's Report. **MOTION # 8- Meyer moved, seconded by Heinrichs to approve the Little Blue Water Project South treasurer's report and payment of bills as presented.** Carried by roll call vote – 14 yes votes

## **AGENCY REPORT**

**NARD Report – Lyle Heinrichs:** Heinrichs reported the NARD is working from home until they have a new office to move into. The NARD fall conference may have to be cancelled.

**NRCS:** Janet Valasek reviewed the happenings in the NRCS offices.

## **EXECUTIVE COMMITTEE**

The Executive Committee met June 25<sup>th</sup>.

**Action to Approve Employee Family Insurance Coverage:** The addition of the benefit to share a portion of employee's family health insurance was proposed. **MOTION # 9 – Kimle moved, seconded by Brakhahn to Approve Employee Family Insurance Coverage at the rate of 30%.** Carried by roll call vote. Yes: Brakhahn, Glenn, Heinrichs, Kellogg, Meyer, Shaw, Taylor, VonSpreckelsen, Wiedel and Kimle. No: Hoffman, Kissinger, Schroer and Trausch.

**Action to Approve Employee Salary FY 20-21 Adjustments:** The Employee salary adjustments were proposed. **MOTION # 10 – Kimle moved, seconded by Brakhahn to allocate \$20,000 (2.65%) in the FY 2021 Budget for staff salary adjustments.**

After discussion Kimle made a friendly amendment and Brakhahn agreed to a friendly amendment to the previous motion to include 3.5% for salary adjustments. Failed by roll call vote. Yes: Brakhahn, Glenn, Kellogg, VonSpreckelsen, Wiedel and Kimle. No: Heinrichs, Hoffman, Kissinger, Meyer, Schroer, Shaw, Taylor and Trausch.

**MOTION # 10 – Hoffman moved, seconded by VonSpreckelsen to approve 2.65% salary be allocated for FY 2021 salary adjustments.** Carried by roll call vote – 14 yes votes.

Action to Approve Managers Salary Adjustment: **MOTION # 11 – Kimle moved, seconded by Brakhahn to set the Manager’s salary at \$115,000 for FY 2021.** Carried by roll call vote – 14 yes votes.

Action to Request for Mill Levy for FY 2021: **MOTION # 12 – Kimle moved, seconded by Hoffman to to adopt the following resolution: BE IT RESOLVED that, in accordance with State Statute 77-3443, the Little Blue Natural Resources District Board of Directors hereby requests a fiscal year 2021 levy allocation of \$2,290,398.21.** Carried by roll call vote – 14 yes votes.

### **PROJECTS AND PLANNING COMMITTEE – Jesse VonSpreckelsen**

The Projects and Planning Committee met prior to the regular board meeting.

Action to Approve Belvidere Drainage Project: The Village of Belvidere requested assistance for drainage improvements. **MOTION # 13 – VonSpreckelsen moved, seconded by Heinrichs to approve the Belvidere Drainage Project for 50% of the total cost not to exceed \$2,345.10.** Carried by roll call vote – 14 yes votes.

Action to Approve Edgar Drainage Project: The City of Edgar requested assistance for drainage improvements. **MOTION # 14 – VonSpreckelsen moved, seconded by Hoffman to approve the Edgar Drainage Project for 50% of the total cost, not to exceed \$3,996.50.** Carried by roll call vote – 14 yes votes.

### **PUBLIC COMMENT**

Russ Ochsner made comment on erosion occurring on his property due to the Roseland Dam being silted in.

### **OTHER BUSINESS**

There was no other business.
