Yes: Bonifas, Bredthauer, Glenn, Hoffman, Hoops, Kenning, Luebben, Meyer. Ochsner, Taylor, VonSpreckelsen and Wiedel. No: Shaw.

Action to Approve FY 2025 Property & Liability Insurance Renewal Quote: The quote for renewal of property insurance was presented for approval. <u>MOTION # 6 – Wiedel moved, seconded by Meyer to</u> approve FY 2025 property & insurance liability renewal quote from FNIC. Carried by roll call vote – 13 yes votes.

Action to Approve FY 2025 Little Blue NRD Water Projects and District General Budgets: The Little Blue NRD and Little Blue Public Water Project FY 2025 budgets were presented for approval. <u>MOTION</u> # 7 – Wiedel moved, seconded by Hoops to approve the FY 2025 Little Blue NRD budget in the amount of \$15,338,007 with a tax asking of 2,120,301.52 and the Little Blue Public Water Project budget in the amount of \$10,648,079. Carried by roll call vote – 13 yes votes.

Action to Approve FY 2025 Little Blue NRD General Property Tax Levy: MOTION # 8 – Wiedel moved, seconded by Shaw that the Little Blue NRD Board of Directors accept the Resolution on the final adoption of FY 2025 budget and property tax request of \$2,120,301.52 which will require a property tax levy rate of 0.019037. Carried by roll call vote – 13 yes votes.
