MOTION # 3 - Glenn moved, seconded by Taylor to approve the Little Blue NRD Treasurer's **Report as presented.** Carried by roll call vote – 17 yes votes.

Glenn reviewed the Little Blue Public Water - North Project Treasurer's Report. MOTION # 4 - Glenn moved, seconded by Bonifas to approve the Little Blue Public Water Project -North Treasurer's Report as presented. Carried by roll call vote – 17 yes votes.

Glenn reviewed the Little Blue Public Water Project - South Treasurer's Report. MOTION # 5 - Glenn moved, seconded by Ochsner to approve the Little Blue Public Water Project - South Treasurer's Report as presented. Carried by roll call vote – 17 yes votes.

AGENCY REPORTS

<u>NRCS Report – Janet Valasek</u>: Valasek gave a brief report on the happenings at the NRCS.

<u>NARD Report:</u> Hoffman reminded everyone of the upcoming NARD conference being held September 25 and 26 in Kearney.

EXECUTIVE COMMITTEE

The Executive Committee met prior to the regular meeting.

<u>Aaron Bos – Nebraska Cooperative Liquid Assets Securities System (Nebraska Class)</u> Bos was unable to be present and requested to be added to the October agenda.

Action to Approve FY 2024 Property & Liability Insurance Renewal Quote: The quote for renewal of property insurance was presented for approval. <u>MOTION # 6 – Wiedel moved, seconded by Knight to</u> **approve FY 2024 property & insurance liability renewal quote from FNIC.** Carried by roll call vote – 17 yes votes.

Action to Approve FY 2024 Little Blue NRD Water Projects and District General Budgets: The Little Blue NRD, Little Blue Public Water Project North and Little Blue Public Water Project South's FY 2024 budgets were presented for approval. <u>MOTION # 7 – Wiedel moved, seconded by Bredthauer to</u> <u>approve the FY 2024 Little Blue NRD budget in the amount of \$4,843,618 with a tax asking of</u> <u>1,746,756.62 the Little Blue Public Water Project North budget in the amount of \$470,312 and</u> <u>Little Blue Public Water Project South budget in the amount of \$462,754.</u> Carried by roll call vote – 17 yes votes.

Action to Establish FY 2024 LBNRD General Property Tax Levy: MOTION # 8 – Wiedel moved seconded by Luebben that the Little Blue NRD Board of Directors accept the Resolution on the final adoption of FY 2024 budget and property tax request of \$1,746,756.62 which will require a property tax levy rate of 0.017509. Carried by roll call vote – 17 yes votes.

Other Business: There was no other business.

WATER RESOURCES COMMITTEE

The Water Resources Committee met prior to the regular meeting.

Motion to Advance Amended GWMP Rules and Regulations to a Public Hearing: Revised Groundwater Rules and Regulations were presented for approval to advance to a public hearing. MOTION # 9 – Hoops moved, seconded by Hoffman to approve the revised Groundwater Rules and Regulations and advance them to a public hearing. Carried by roll call vote – 17 yes votes.

Action to Formally Lift Cease and Desist Orders for Operators in Compliance One operator remained in non-compliance with the district's Groundwater Rules and Regulations soil sampling rules and was issued a Cease-and-Desist letter; the operator submitted the required report. MOTION # 10 – Hoops moved, seconded by Hoffman to lift the Cease and Desists Order for the operator who submitted the required soil sampling reports.

<u>Review 2023 Nitrate Report</u>: Goeschel reviewed the 2023 Nitrate Report compiled from water samples taken across the district. After discussion it was decided to address this further at the October meeting.

Other Business: There was no other business.

PROJECTS AND PLANNING COMMIT

The Projects and Planning Committee met prior to the regular meeting.

Motion to Approve Engineering Contract with Miller & Associates for LBPWP: The contract from Miller & Associates for the Municipal Water System Improvements was presented for approval. Chris Miller was present to answer questions. <u>MOTION # 11 – Luebben moved, seconded by</u> <u>VonSpreckelsen to approve the contract from Miller & Associates for the engineering fees for the</u> <u>Little Blue Public Water Projects municipal water system improvements.</u> Carried by roll call vote – 17 yes votes.

<u>Motion to Approve WSF Funding Contract for LBPWP:</u> A contract for a grant award for the Little Blue Public Water Projects improvements from the Department of Natural Resources Water Sustainability Fund was presented for approval. <u>MOTION # 12 – Luebben moved, seconded by Hoffman to approve</u> <u>the State of Nebraska Department of Natural Resources Water Sustainability Fund Grant Award</u> <u>in the amount of \$3,919,500 to be used for the Little Blue Public Water Projects municipal water</u> <u>system improvements.</u> Carried by roll call vote – 17 yes votes.

<u>Motion to Approve Archaeological Investigation Bid for LBPWP</u>: Two proposals were received for an archaeological survey for the LBPWP municipal water system improvements. <u>MOTION # 13 – Luebben</u> moved, seconded by Hoeft to approve Rob Bozell to conduct the archaeological survey for the Little Blue Public Water Projects municipal water system improvements in the amount of \$10,328. Carried by roll call vote – 17 yes votes.

<u>Motion to Approve Land Right Agreement for LBPWP</u>: No action was taken. Nelson and Miller reviewed what is needed to obtain land rights for LBPWP municipal water system improvement project.

<u>Review/Approve Bid for New Playground Equipment at Prairie Lake:</u> Three bids were received for playground equipment to be installed at Prairie Lake. <u>MOTION # 14 – Luebben moved, seconded by</u> <u>Kenning to accept the Synergy SY-2410 bid in the amount of \$27,620 for the purchase and installation of playground equipment at Prairie Lake Recreation Area.</u> Carried by roll call vote – 17 yes votes.

Other Business: There was no other business.

OPEN PUBLIC COMMENT PERIOD

David Endorf asked if the Glenn family will be required to abandon their irrigation well on the property the LBPWP plans to install their municipal water wells due to concerns for neighboring irrigation wells. Endorf stated he feels well site 5 is a poor site to install a well due to nitrate concerns, he recommended using well site 3 instead. He asked what the hidden agenda is for installing the municipal water system wells. Miller explained why they chose the well locations, the difference in municipal well and irrigation well construction and how the municipal wells work. Endorf expressed concern for the future of neighboring wells.

OTHER BUSINESS

Nelson reported on discussion that was held at the recent manager's meeting regarding Nebraska Farm Bureau's suggestion for possible changes to the NRD taxing authority.
